

**PENALTIES PERTAINING TO VIOLATIONS ON PEC ADMISSION CRITERIA AND INTAKE POLICES AS APPROVED BY 23<sup>RD</sup> PEC GOVERNING BODY**

**A. Policy pertaining to admission criteria:**

Sr No	Violation by HEI	Imposed Penalties
1.	Admission granted by university/HEI to students without pre-engineering background, as prescribed in Article 2 of PEC Regulations for Engineering Education in Pakistan.	
2.	Admission granted to students having less than 60% marks in F.Sc (Pre-Engineering)/ Equivalent qualification as prescribed in Article 2.(a)(i)	i. Rs. 500,000/- per student admitted.
3.	Students having HSSC (General Science) qualification admitted to a non-computer related engineering discipline in violation of Article 2.(a)(i) of PEC Regulations, after 67th EA&QEC meeting held on Sep 30, 2013.	ii. In case of non-compliance by the HEI, specific batch of student enrolled shall be de-notified besides suspending all its running programs with PEC. The HEI shall refund the semester fee to each student immediately.
4.	<p>a. Admission granted to students having less than 60% Marks in DAE against reserved seats (<i>2% of total allowed intake as fixed by PEC</i>).</p> <p>b. Admission in Engineering program having irrelevant DAE, as per relevancy determined in 68th EA&amp;QEC meeting held on February 10, 2014 (<i>available on PEC website</i>)</p>	<p>The fresh case, in a subsequent year to apply through a Zero Visit request for re-launching the program, can only be accepted by PEC after compliance of all penalties imposed.</p> <p>iii. The matter shall also be reported to the Chancellor concerned, HEC, and HED of the respective province for their necessary action as per rules and regulations.</p>
5.	If student is transferred from an un-accredited or non-engineering program to an accredited engineering program	
6.	HSSC (Pre-Engg.) with less than 60% marks w.e.f Fall 2015 (after withdrawal of Zero/Qualifier exam provision from regulation)	

7.	HSSC (Pre-Engg.) with less than 60% marks and Zero/Qualifier not conducted after S.R.O No. 745 (1)/2009 dated August 20, 2009 (intake enrolled upto Spring 2015)	<p>A letter be issued (after the approval of PEC Governing Body) to all HEIs concerned to approach PEC to regulate their violation of this particular provision given under Article 2(a)(i) of PEC Regulations for Engineering Education within 60 days from the issuance of this letter alongwith detailed plan/schedule to conduct zero semester and qualifier exam. Maximum two chances shall be given to student(s) to qualify.</p> <p>In case of non-compliance, the same penalties shall be applicable/ imposed as mentioned above in para 1-6.</p>
8.	If university admits student on basis of B.Sc qualification (after SRO dated July 28, 2001).	<p>Permission may be granted to such students subject to attainment of at least 60% marks in B.Sc (two years program) with combination of Physics, Chemistry and Mathematics against reserved seats of 10% of the total allowed intake of PEC. Revised SRO may be issued in this regard.</p> <p>In case of non-compliance, the same penalties shall be applicable/ imposed as mentioned above in para 1-6.</p>

### **B. Policy on Approved/Allowed Intake by PEC**

Zero tolerance shall be exercised for violation of allowed intake and shall be strictly implemented w.e.f. Fall 2015. All institutions shall forward the data of enrolled students within one month after start of session for maintaining student's record in PEC as per the given format attached (Annex-B).

In case of violation, following penalties/actions shall be imposed/ taken by the council.

The same will be published in daily newspaper and PEC website</p> <p>Rs. 100,000/- per student per semester will be charged as penalty from HEI. Students shall not be made responsible for this penalty.HEI may</p>

	record in PEC as per the given format (Annex-B).	appeal PEC within 15 days in compliance of above penalties and proof of de-registering excessive students.
2.	If a HEI has admitted students more than the allowed intake of PEC before Fall 2015.	<p>Rs. 100,000/- per student will be charged as penalty from HEI. Students shall not be made responsible for this penalty.</p> <p>Notice should be served immediately to deposit the penalty in favor of PEC in intimation to EAD (Accreditation Department).</p> <p>Incase of non-compliance, accreditation/re-accreditation of batch(s) shall not be entertained besides suspending all its running programs with PEC.</p> <p>HEI are given deadline to appeal PEC by October 30, 2015 to avail one-time amnesty provided compliance of above penalties.</p>
