**No. PEC/M&E/SBDs/Amend/Civil-07/2024:** Consequent upon update/ revision of Standard Bidding Documents on construction works/ services generally referred to as SBDs-2007, which are available on website of Pakistan Engineering Council (PEC), PEC is pleased to make following modifications therein:

- a. Nomenclature of 'Standard Bidding Documents' is changed to read and call as 'Pakistan Standard Bidding Documents', for all future references.
- b. After notification of '*Pakistan Standard Bidding Documents Construction Works for Building and Engineering Works Designed by the Employer (Following Prequalification), December 2023*' vide notification No. PEC/M&E/SBDs/Civil/2024 dated March 12, 2024, which is available on PEC website, the previous document titled as '*Standard Form of Bidding Documents (Civil Works), 2007*' is moved to Archive Section of PEC website where it is available as reference for all the contracts made before April 01, 2024 by using this document.
- c. The maximum project value related with applicability of document titled as '*Standard Form of Bidding Documents for Procurement of Works for Smaller Contracts (2007)*' which is available on PEC website, is amended from existing PKR 25 Million to PKR 100 Million, wherever it appears in the said document.

Above mentioned modifications shall be implemented with immediate effect.
