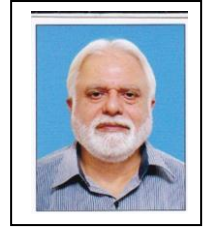

Got promoted in own Department (Pak. PWD) as Executive Engineer (BS-18) and worked at Sahiwal, Islamabad, Bannu, Karachi, Peshawar & Quetta up till 2006. Got promoted as Superintending Engineer (BS-19) and worked at Multan, Islamabad, Lahore & Karachi with current charge of Chief Engineer (BS-20) in year 2009 after having successfully completed the Senior Management Course at NIPA Lahore. Represented Pakistan at Nepal as a nominee of the Government of Pakistan for a Workshop held of SAARC Countries.
