The total covered area of all the buildings is around 300,000 Sft.

- i. Duly Registered firms should have an experience of similar interior space designing of not less than 10 (ten) years.
- ii. Proof of having executed similar works in the last 10 (ten) years especially in multistory corporate buildings interiors.

Interested Firms are requested to submit:

- 1) A company profile clearly articulating their services, value proposition, organization structure and key projects
- 2) Specific experience of relevance to the assignment including:
 - a. 1 (one) interior design project of 50,000 square feet or above, along with 3D rendering of the project in presentation format
 - b. 5 (five) other projects of interior design completed in the last 10 years
 - c. Project details of similar projects in hand
- 3) Team composition includes:
 - a. Proposed Team structure for undertaking the project
 - b. CV of Team Leader/ Lead Designer who should currently be an employee of the Firm
 - c. CVs of 5 (five) team members likely to be associated with the proposed project

Firms meeting the qualification criteria may be required to provide a presentation of their capabilities to the PEC on a date notified after the submission of pre-qualification documents.

The deadline for submission of the pre-qualification is **5.00 p.m. PST on Oct 28, 2024 (Monday)**. All pre-qualification documents must be delivered to the address below along with a soft copy of the same on email. All late submissions will be rejected.
